## What you will do:

- Landlord Insurance
  - Verify that Agree Realty has the appropriate coverage on our owned properties and that the Certificates of Insurance (COIs) include any tenants that are required to be listed as additional insureds.
  - Primary responsibility for all claims filed.
  - Respond to requests from tenants asking for copies of Landlord's COIs.
  - Responsible for getting any necessary COIs related to the due diligence process.
  - Onboard new acquisitions & development with external vendors.
- Tenant Insurance
  - Verify the COIs have the coverage required by the lease.
  - o Collect COIs from Tenants that have not submitted and meet internal goals for compliance.
- Insurance Claims
  - Formulate, report, and manage all aspects of commercial insurance claims ranging from management liability, general liability, property, pollution liability, cyber, fiduciary liability, automobile liability, and worker's compensation to conclusion. This also includes management of all claims, up to and including responding to interrogatories and attending mediation for litigation claims.
